- 1. Work hours** 8:00am-8:05pm, individual work schedules vary. Library is open 7 days/week. An employee clears the book drop on holidays.
- 2. Overtime** Library is not budgeted to pay overtime. Rare exceptions require the Director's approval in advance.
- 3. Licensure or certification required for library positions** Director's position requires an MLS degree. Library accreditation requires Director to meet State Library standards for continuing education. For Youth Services Librarian, an MLS degree or prior teaching experience is preferred.

Physical Requirements

- 4. Maximum duration an employee is required to do the following activities** Standing: 40-60% Walking: 20% Sitting: 20-40% = Total 100%
- 5. The work environment is** Inside: 95% Outside: 5% = Total 100%
